On the basis of the Labour Relations Act (ZDR-1), Article 12 of the Collective Agreement for Cultural Activities in the Republic of Slovenia in conjunction with Article 47a of the Act on the Realization of the Public Interest in Culture (Official Gazette of the Republic of Slovenia, No. 77/07 - officially revised text, 56/08, 4/10, 20/11, 111/13 and 68/16), the Public Institution SNG Opera and Ballet Ljubljana is announcing an audition for the following position:

- **Ballet dancer soloist** - G017005 (one female dancer),

### - DESCRIPTION OF WORKS AND CONDITIONS:

#### **BALLET DANCER SOLOIST - G017005**

The basic salary class of the position is the 38th salary class, i.e. EUR 1964.17 gross.

#### **Description of works:**

- dancing demanding, medium and less demanding solo roles in ballet and opera performances, recordings and in ballet parts of opera performances according to the OE Ballet program;
- participation in conditioning exercises and regular artistic training;
- participation in orchestral rehearsals, main, general rehearsals and performances, participation in masks and costumes;
- co-designing individual dance characters and perfecting the technical, dance and acting requirements for certain dance forms;
- a direct superior orders work to an employee who is subordinate and in accordance with Article 34 Rules on the organization of work and the systematization of jobs in SNG Opera and Ballet Ljubljana.

**Conditions for filling the position:**

- level VII/2 of the relevant artistic fields
- successfully completed audition

Due to the candidate's ability, a successful audition can exceptionally replace the missing education required to fill the position, but for a maximum of two levels.

**Responsibility:**

- is responsible for fitness and artistic preparation
- is responsible for quality technical and artistic performance of assigned roles in performances
- reports to the assistant director for managing artistic professional work for the field

**Duration of employment and probationary period:**

The selected candidate will be employed full-time for a period of one year with the possibility of extension, with a six-month trial period.

**Only selected and invited candidates may attend the audition.** Audition is expected to take place on **March 30, 2024**. Selected candidates will receive the invitation by March 11, 2024.

Candidates will be notified of their selection no later than 10 days after the audition.
